HAF Programme Timeline

Please ensure that you have these dates in your diary:

Week Commencing 25 July to 2 September

The team will start to visit HAF Programmes to see what wonderful opportunities you are providing to the children and families. New partners will be prioritised, but we hope to visit as many partners and sites as possible. These will be followed up with notes of visit, but please be patient as undertaking the visits remains a priority.

5 August

Interim monitoring forms must be returned by this date, more information will follow. Any received after this date will not be processed as quickly and you will not receive your second payment until someone is available to process them as the team will be out on visits.

16 September

The final date for monitoring forms to be submitted – further information will follow. If you can submit your forms earlier, please do so. The team aims to process the monitoring forms in the order in which they are sent in.

Monday 3 October

The planned date for our network meeting in Aylesham, to be confirmed.

Tuesday 11 October

The planned date for our network meeting in Maidstone, to be confirmed.

4 November

The final date for applications to run a programme at Christmas, update forms will be sent out prior to this.

No10 Event Celebrating HAF Programme Partnerships

On Tuesday the Secretary of State for Education alongside a cross-Government ministerial team hosted a meeting at No10 to celebrate the successes to date and focus on how we can build on the already established local partnerships for the HAF Programme. Following this meeting a Press Release has been published which provides further information.

Ofsted Registration

Holiday clubs may need to legally register with Ofsted depending on the provision they offer, they may also be eligible to register with Ofsted on the Voluntary register or they may be <u>exempt from registration</u> entirely. Both clubs and providers that would require registration with Ofsted, and those that are exempt, can participate in the holiday activities and food programme.

To support the raising of quality and to better meet the safeguarding needs of children and young people, certain providers can choose to register even if they do not have to via the Gov.uk website.

One of the direct benefits to children and families of providers being Ofsted registered is that families may be eligible for Tax-Free Childcare or the childcare costs element of Universal Credit. Through this families may be able to claim back up to 85% of their childcare costs if they are attending and paying for extra childcare at Ofsted registered settings.









It is the legal responsibility of individual providers to understand whether or not they should be Ofsted registered and to continue to review their status as and when the provision they are offering changes.

Financial Support for Childcare - Message for providers

With the school summer holidays approaching, it is more important than ever that parents and carers can access the financial support they qualify for. It can reduce their costs, help them to stay in work, or help them work more hours if they wish to.

To help childcare providers to offer this support, the Department for Education (DfE) has produced a new toolkit which will help you to raise awareness of existing Government schemes of financial support for childcare. This could in turn help you boost your business.

Over a million families in the UK are entitled to some form of Government childcare support, but many are missing out because childcare providers in their area haven't signed up to accept the various offers.

That means that many childcare providers are missing out on boosting their businesses by increasing demand as they aren't accessible to families who use Government childcare support.

The toolkit contains a step-by-step guide to ensure that you have all the elements in place for your services to be accessible to families who use Government childcare support.

It also includes resources to raise awareness of the different offers available amongst families in your networks, whilst advertising that you are one of the providers equipped to accept the different types.
