Safer Recruitment Checks

The team have started to work with all HAF Programme partners to ensure that they have a robust system of recruitment checks in place for staff who work on the HAF Programme. We will be continuing with these checks and will be in touch with partners who have not yet had their checks completed. You are required to undertake these checks even if staff are self-employed. It is good practice to carry out a new DBS check on all staff and not to rely on checks undertaken by other organisations.

We include the template that has been sent out previously, and an excel version which some partners may find easier to work with. Many partners already have their own systems in place; we do not expect you to change these. If you have any questions around this, please contact the HAF inbox.

Ofsted

Many partners are now registering with Ofsted. This helps them to build their business and allows families to use childcare vouchers to top up the hours provided through the HAF Programme. We strongly recommend that all partners register with Ofsted. Partners who are not registered are limited in the way that they can deliver the HAF Programme.

Signposting Families

Our visits in 2023 demonstrated that some partners struggle to signpost families to further information, so we are including information in this newsletter which can be used to support both your staff teams and your families. Please share this information as part of your signposting.







Maya's Community Cafe

Maya's Community Support Café is based in Herne Bay and is open to all Kent residents. Maya's has an open Food Bank with no registration, referral process or proof of benefits. This is open to all, with a selection of fresh food and tins stocked every day. There is a free shop with an array of clothes, shoes, toys, bedding, blankets, beds, household items and bric-a-brac. These items are free unless the person would like to give a donation. Free haircuts are offered to those struggling with the cost of living. There are also various drop-in sessions for all to access with support and advice given on money, housing and employment.

The concept of a free shop is unique and popular, especially given the cost-of-living crisis. It reduces waste and brings the community together to support one another. Maya's has captured the attention of national news outlets who have run several stories on the shop. Kent County Council social services regularly refer families who have escaped domestic violence to the free shop where they can be kitted out with everything they need to start again. All for free.

Please keep Maya's Community Support Cafe in mind when working with families, especially those that work in the Canterbury District. We would advise that you go and speak to Maya about your HAF Programme and how you support families; she has some amazing connections in the community. Citizens Advice: Money and Perinatal Mental Health - The Citizens Advice Money and Perinatal Mental Health Service is for new parents or soon-to-be parents in Kent who are struggling with money and mental health. It provides free, confidential and impartial money advice and support to help people take control of their finances. A dedicated specialist adviser provides support to:

- · deal with any debt
- manage money better
- · identify and claim new benefits
- improve mental health, wellbeing and more.

Asthma Training – to share with staff and families

The NHS has training available for all who care for children and young people with asthma to help improve their understanding and awareness of the issue.

The e-learning for health website has free <u>online training</u> for all levels of professionals who work with children and young people (CYP) with asthma.







We encourage anyone who supports children and young people to complete this free online training. This may include, but is not limited to:

- teachers and school support staff
- youth workers
- children's group leaders (e.g. wraparound and holiday clubs, uniform groups, sports and hobby clubs)
- staff working in Children and Family Centres
- social care and housing staff
- parents, carers, and friends of young people with asthma.

Support for Kent's Young Carers

If you are supporting a child or young person who has caring duties for a family member with a long-term illness, disability, mental health or substance misuse issue, or who provides emotional support for a sibling with SEND, you can refer them to our Young Carers service.

The Kent Young Carers service offers a range of short-term interventions including signposting, one-to-one support, in school support and workshops. Young carers are also entitled to a **free bus pass**.

SAFEGUARDING

Designated Safeguarding Lead Training

Please be reminded that any certification for this only lasts two years. We strongly recommend that you have at least 2 DSL trained staff to ensure that someone is available in the event of unexpected issues or sickness with one member of the team. Whilst we expect each partner to have someone with up-todate Designated Safeguarding Lead training this is a reminder that we strongly recommend that each site manager has undertaken this training, with two trained staff on sites which accommodate over 100 children.

Underneath login it says - create account https://app.melearning.co.uk/auth/selfregistration/HPBNWSDT and you can set up an account on the form.

- Once you have clicked **create account** it takes you to a form, do not be put off by the key that it asks for, let the circle whirr for a moment and the form pops up
- You then **create your username and login** (keep a note of this for the future)
- You will then be asked **your unit** if you scroll down under Kent and Medway there are individual applicants listed. We would suggest this is the category that you should register under.
- Once you have completed the form and submitted it you will receive a verification email which allows you to use the email and login.
- Once you have set up your account go back and login.
- It comes up as my courses. You can then click on courses (along the bar at the top) and they all come up.
- If you scroll down, you can see the courses that are available.
- Scroll down further and e-learning courses are listed.







• You are looking for **child safeguarding for designated practitioners.** It is at the top of the list and there are currently places available.

Please follow the instructions bellow:

Once you have completed the training you will need to go back to your account. You may need to do a course evaluation. Once this is done it generates the certificate into your account and you can then **download the certificate** and send it to us.

Please ensure that you have sufficient staff trained to this level.

HAF Safeguarding Training

Safeguarding Awareness - HAF programme E-Learning course can be accessed via The Education People website.

This is intended to be an introductory safeguarding E-Learning course to ensure that all staff have the essential knowledge and skills needed to recognise, report and record child safeguarding concerns and this course highlights the local Kent processes. Please enter the following voucher code at the checkout to access this training for free: HAF23. Please note this code must not be shared with anyone outside your organisation.
